 - a. 2012 ASA President: Erin Olin Wright
 - b. Theme for next year's meeting: Real Utopias: Emancipatory Projects, Institutional Designs, Possible Futures
 - c. Deadlines: November 2010 (thematic sessions); February 2011 (regional spotlight/special sessions)
 - d. Thematic sessions already organized
 - i. Worker-owned cooperatives
 - ii. Workers' search for utopia
 - e. If we combine Roundtables and Business Meeting, that doesn't count against our session total.
 - f. Brainstorming session ideas
 - i. Council's suggestions
 - 1. one international session & one U.S.-focused
 - 2. Utopia for who? (class, race, gender dimensions, etc.)
 - 3. Neoliberalism as utopia (Section members suggested some possible forms for this including university restructuring, contingent employment, etc.)
 - 4. Immigrants' rights & movements away from dystopia; alternatives to Arizona
 - 5. Health & labor
 - 6. Possible co-sponsoring sections: global/transnational section, international migration, Altruism/Morality/Solidarity, Inequality
 - ii. Ideas from members
 - 1. Labor & globalization; possible co-sponsoring sections: Marxist section; PEWS section
 - 2. Economic sociology & the sociology of labor/labor movements: what can we learn from each other? (especially on financialization of the economy & how public policy makes a difference)
 - 3. Comparing India & China (or possibly even a broader comparison: also Brazil, others?). Comparison of social movements in the Global South?

- iii. Chris Tilly said that if any of the above ideas were not used for the 2012 ASA conference, we would keep them in mind for the 2013 meeting and the upcoming 2013 mini-conference
- VIII. Update on ISA, Research Committee 44: Labor Movements (Jennifer Chun)
 - a. 2012 is the midterm meeting and then the next World Congress meeting is 2014, so 2013 for the section mini-conference works well; we should get RC44 cosponsorship for the mini-conference
 - b. Michael Burawoy is the next ISA president
 - c. Over the past 8-10 years, ISA has grown and RC44 has contributed to the growth and vitality of this association
 - d. ISAS forum meeting is 8/1-8/4, 2012 in Buenos Aires; theme: social justice & democratization; 14 sessions are planned; 12/15/11 is final deadline for submissions
 - e. 3 types of sessions are organized at ISA (standard panel; roundtables; practicums on topics we need to know more about)
